In keeping with the District of Columbia's commitment to transparency in contracting and increased competition and in compliance with Rule 27-4719, the Department of General Services publishes emergency procurement contract information. All emergency awards are posted no more than 7 days after contract award.

What is the DC office of contracting & procurement (OCP)?

This portal is a public clearinghouse for all information related to the DC Government's contracting and procurement efforts. The DC Office of Contracting and Procurement (OCP) is required to post contract awards valued at \$100,000. Questions about doing business with the District government?


