

How much is the tariff exemption for solar glass in Ghana





Overview

The zero rate applies to Agricultural and Industrial Machinery, Solar, Wind and Thermal Generating Sets, Electric Generating Set of 375 KVA and above, Solar Cells and Panels as well as Educational Materials. Does Ghana have a fish import duty exemption?

NB: The Import Duty exemption on fish caught by Ghanaian owned vessels and canoes within the EEZ (Exclusive Economic Zone) and fish from ECOWAS territorial waters remains unchanged. In addition to this 5% import duty is now levied on materials for the manufacture of or prospecting for timber and other natural products.

What are the duties & charges of the Ghana Revenue Authority?

The Customs Division of the Ghana Revenue Authority is responsible for the collection of import duty, import VAT, export duty, petroleum tax, import excise and other taxes, levies and fees. Other Duties and Charges: Ghana collects numerous duties and charges on imports in addition to the customs tariff and VAT.

What percentage of imports are exempted from import duties in Ghana?

Introduction About 40 percent of imports officially cleared through Customs in Ghana are exempted from import duties. This does not include imports which enter at zero statutory rates, and under some kind of concessionary rates.¹ The wide use of exemptions raises procedural, incentive and revenue issues.

What is a customs exemption in Ghana?

In Ghana, certain goods are eligible for exemptions from customs duties, which can significantly reduce the cost for importers. These exemptions are typically outlined in the country's customs laws and regulations, aimed at supporting specific economic activities or sectors.

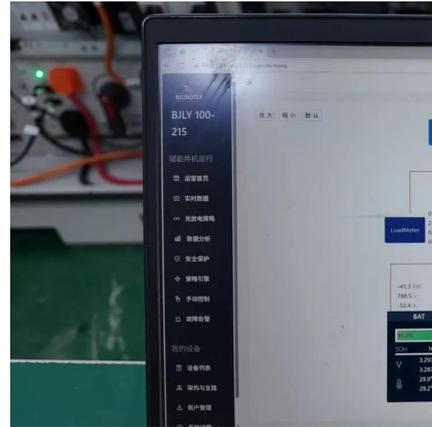


