# Implementation Plan for Energy Storage Electricity Price Reform





## Overview

---

Since February 2025, when the National Development and Reform Commission (NDRC) and the National Energy Administration issued the "Notice on Deepening the Market-oriented Reform of New Energy Feed-in Tariffs to Promote High-quality Development of New Energy," explicitly abolishing the mandatory energy storage requirements for new energy projects, the national and local levels have successively introduced a series of new policies. What is the implementation plan for the development of new energy storage?

In January 2022, the National Development and Reform Commission and the National Energy Administration jointly issued the Implementation Plan for the Development of New Energy Storage during the 14th Five-Year Plan Period, emphasizing the fundamental role of new energy storage technologies in a new power system.

How to promote the implementation of independent energy storage stations?

To promote the implementation of independent energy storage stations, it is necessary to further optimise the electricity market mechanism, segments and targets. Investor participation is beneficial for the development of the energy storage industry.

Will China develop new energy storage systems between 2025 and 2027?

BEIJING, Sept. 12 -- China on Friday unveiled an action plan to promote the development of new forms of energy storage between 2025 and 2027, amid efforts to support green energy transition and ensure the stability of new-type power systems.

What is the energy storage plan?

The plan outlined 21 key measures, including scaling up energy storage applications in power generation and grid infrastructure, accelerating technological innovation, and improving standardization. It also emphasized talent development and enhancing international cooperation in the sector.




