What is ICI's purchase of goods & sales policy 2024?

Like all government Ministries and Agencies are required to, ICI follows the Cook Islands Government's Purchase of Goods and Sales Policy 2024. Request for Tenders Tenders are for the purchase of goods and services \$200,000 and above. You must be registered to the government's web based Procurement Portal submit a tender bid.

How do I participate in tenders or quotes issued by Cook Islands Government?

In order to participate in any tenders or quotes issued by Cook Islands Government you will need to register as a supplier on the Portal and you are invited to do this at your convenience. As part of registration you will need to specify relevant "Business Categories" for your business.
